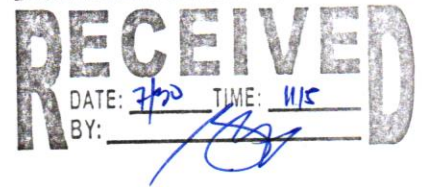

In line with the implementation of Republic Act No. 12009 (New Government Procurement Act) and its Implementing Rules and Regulations, and pursuant to the school's continuing efforts to strengthen procurement planning and implementation, Bataan High School for the Arts (BHSA) shall conduct a **Training-Workshop on Market Scoping and the Bidding Process** on **August 13-14, 2026, within Clark, Pampanga.**
2. The training aims to enhance the knowledge and competencies of procurement practitioners in conducting effective market scoping, preparing procurement requirements, selecting the appropriate procurement modality, and managing the bidding process in accordance with Republic Act No. 12009 and its Implementing Rules and Regulations.
3. Specifically, at the end of the two-day training-workshop, participants are expected to:
 - a. Conduct effective market scoping and market research to support procurement planning, cost estimation, and the preparation of technical specifications;
 - b. Apply the provisions of Republic Act No. 12009 and its Implementing Rules and Regulations in determining the appropriate procurement modality and carrying out the bidding process; and

- c. Prepare essential procurement documents through workshop activities to ensure efficient, transparent, and compliant procurement implementation at Bataan High School for the Arts.
