FOR SY 2026 - 2027**

1. Pursuant to **DepEd Order No. 40, s. 2012**, entitled *DepEd Child Protection Policy*, the **School Child Protection Committee (CPC)** of the Bataan High School for the Arts is hereby reconstituted. To enhance the implementation of child protection mechanisms to foster a safe, secure, inclusive, and learner-centered educational environment.
2. The reconstitution of the Committee aims to:
 - a. Strengthen the implementation of the School's Child Protection Program;
 - b. Ensure the timely reporting, management, and monitoring of child protection concerns;
 - c. Promote positive discipline and uphold the rights and welfare of learners;
 - d. Enhance coordination among school offices, parents, and external stakeholders in protecting children from all forms of abuse, violence, bullying, exploitation, discrimination, and neglect; and
 - e. Ensure compliance with existing DepEd policies, national laws, and child safeguarding standards.

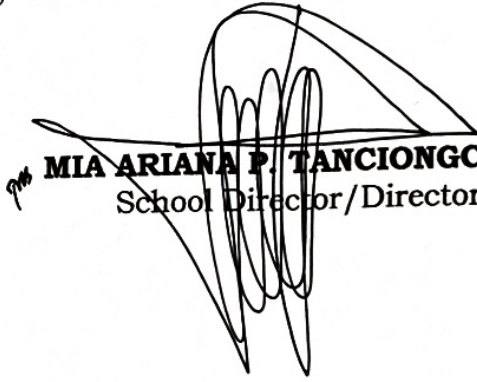
4. The Committee shall perform the duties and responsibilities prescribed under DepEd Order No. 40, s. 2012, including but not limited to:

- Develop and oversee the implementation of the School Child Protection Program;
- Receive, document, and facilitate appropriate action on child protection concerns in accordance with existing laws and DepEd issuances;
- Promote positive discipline and child-friendly practices within the school community;
- Conduct advocacy, orientation, and capacity-building activities on child protection;
- Coordinate with parents, local government units, social welfare offices, law enforcement agencies, and other stakeholders, whenever necessary;
- Monitor the implementation of child protection interventions and recommend policy enhancements to improve learner safety and well-being.

5. The Committee shall convene regularly and whenever necessary to address child protection concerns and submit periodic accomplishment reports and recommendations to the School Director.
6. All school personnel are enjoined to extend their full cooperation and support to the Child Protection Committee in the performance of its functions and in fostering a culture of safety, respect, accountability, and child protection throughout the school community.
7. This Memorandum shall take effect immediately upon issuance and shall remain in force until revoked or superseded by a subsequent issuance.
